RESPECTIVE FUNCTIONS OF THE BOARD OF GOVERNORS AND PRINCIPAL IN RELATION TO ADM ISSIONS

The Board of Governors draw up and apply the criteria for admissions.

ADMISSIONS CRITERIA

During the admissions procedure when applying the criteria <u>punctual applications</u> will be considered before <u>late applications</u> are considered. The application procedure opens on 10 January 2022 at 12noon (GMT) and an application submitted by the closing date of 28 January 2022 at 12noon (GMT) will be treated as a <u>punctual application</u>. An application received after 12noon (GMT) on 28 January 2022 will be treated as a <u>late application</u>.

The Board of Governors will apply the following criteria in the order indicated to identify which children should be admitted either at initial admission to education or on transfer from another school.

- 1. Children who have brothers or sisters in attendance during the 2022/2023 school year.
- 2. Children whose brothers or sisters previously attended the school.
- 3. Children whose parents/guardians, grandparents, brothers, sisters, aunts, uncles, cousins are members of the staff of Mount St Catherine's Primary School.
- 4. Children whose parents/guardians, grandparents, aunts or cousins attended the school.
- 5. Children with special circumstances (social, medical or security). The special circumstances must be made known at the time of application. The Board of Governors reserves the right to seek confirmation of the special circumstances from a statutory body.
- 6. Proximity of the child's home to the school, priority being given to those living nearest to the school.

Criterion 6 will also be used as a deciding factor where there is over-subscript ion within a criterion.

DUTY TO VERIFY

The Board of Governors reserves the right to require such supplementary evidence as it may determine to support or verify information on any application.

If the requested evidence is not provided to the Board of Governors by the deadline given, this will result in the withdrawal of an offer of a place. Similarly, if information is supplied which appears to be false or misleading in any material way, the offer of a place will be withdrawn.
